(LONG PAUSE)

(TELEPHONES RINGING, NOT BEING ANSWERED)

PAPD - OFFICER MOORE: Port Authority Police, Officer Moore.

MALE - PACKAGE COUNTER: Yeah, Officer Moore, this is (Inaudible) at the package

counter.

PAPD - OFFICER MOORE: Yes?

MALE - PACKAGE COUNTER: Did you get a call for a bomb or something?

PAPD - OFFICER MOORE: They got an explosion at the Trade Center, correct.

MALE - PACKAGE COUNTER: Okay, all right.

PAPD - OFFICER MOORE: Right, bye. (PAUSE)

(PHONE RINGING)

MALE ON RADIO: (Inaudible), copy? Patrol to (Inaudible).

PAPD - POLICE DESK: Yes, this is the police desk.

MALE CALLER: Hi, you shut down service into the World Trade Center?

PAPD - POLICE DESK: Right, we are going to bypass. We'll get all our people out of there.

MALE CALLER: All right, thank you.

PAPD - POLICE DESK: Right-o. (PAUSE)

(PHONE RINGING)

PAPD - TOMMY CASHIN: Port Authority Police, Cashim.

PAPD RAY: Tommy, what happened?

PAPD - CASHIM: We got a report that it may be an aircraft.

PAPD RAY: They (Inaudible)?

PAPD - TOMMY CASHIM: We don't have anything further on that, Ray.

PAPD RAY: Okay, talk to you.

PAPD - TOMMY CASHIM: All right, bye. (PAUSE)

(PHONE RINGING - NOT PICKED UP)

(CONVERSATION IN OFFICE)

MAN: He's fine, he says he isn't at the World Trade Center. He's (Inaudible).

RECORDING: We're sorry, all circuits are busy.

(PHONE RINGING - NOT PICKED UP)

(UNINTELLIGIBLE RADIO TRANSMISSIONS HEARD IN BACKGROUND)

(PHONE RINGING)

SERGEANT WOZACK: Sergeant Wozack.

PAPD TOMMY CASHIN: Hey, Sergeant Wozack, is there a mobilization there?

SERGEANT WOZACK: Yes, there is.

PAPD TOMMY CASHIN: All right.

SERGEANT WOZACK: Who is this?

PAPD TOMMY CASHIN: Cashin.

SERGEANT WOZACK: Oh, Cashin, how are you, Tommy?

PAPD TOMMY CASHIN: All right, I know (Inaudible).

SERGEANT WOZACK: Okay, good, everybody over. Bye.

PAPD TOMMY CASHIN: Bye. (PAUSE)

(PHONE RINGING)

PAPD TOMMY CASHIN: Port Authority Police, Cashin.

PAPD MIKE: Tommy, it's Mike, how are you doing?

PAPD TOMMY CASHIN: Hi, Mike, how are you?

PAPD MIKE: Are they calling people?

PAPD TOMMY CASHIN: They're going to find out right now.

PAPD MIKE: Okay, okay, I'll get back to you.

PAPD TOMMY CASHIN: Wait. (To personnel at the station) What do you need? (PAUSE)

Okay, Mike?

PAPD MIKE: Yeah.

PAPD TOMMY CASHIN: Yeah, they're calling in.

PAPD MIKE: Okay.

PAPD TOMMY CASHIN: All right?

PAPD MIKE: All right.

PAPD TOMMY CASHIN: Bye.

PAPD MIKE: All right, bye. (PAUSE)

(PHONE RINGING - NOT PICKED UP)

OPERATOR: Hello.

MALE CALLER: Yeah, can you do me a favor? Get me (Inaudible) line for (Inaudible) gotta

talk to the Mayor, okay?

OPERATOR: Give me the number.

MALE CALLER: All right, what's the number? All right, it's 212-788-3058.

OPERATOR: 3058. All right. Hold on.

MALE CALLER: Okay. (Number being dialed) (Busy)

OPERATOR: It's busy.

MALE CALLER: It's busy.

OPERATOR: Yeah.

MALE CALLER: All right, can you try 788-6688.

OPERATOR: All right, I'm going to try and do this without losing you. But if I lose you, have

MALE CALLER: Thank you. (PAUSE)

PAPD JOHN O'DONNELL: Port Authority Police, O'Donnell.

PAPD JIMMY: Hey, John, is the 33rd Street train working for me?

PAPD JOHN O'DONNELL: I don't know, Jimmy.

PAPD JIMMY: All right.

PAPD JOHN O'DONNELL: I know they got trains ... they may have trains running there, but I

don't know for sure.

PAPD JIMMY: All right, because that's the only way I can come in. Okay, goodbye.

PAPD JOHN O'DONNELL: All right. (PAUSE)

PAPD JOHN O'DONNELL: Port Authority Police, O'Donnell.

FEMALE CALLER: Is Tom Cashin there?

PAPD JOHN O'DONNELL: I'm sorry?

FEMALE CALLER: Is Tom Cashin there?

PAPD JOHN O'DONNELL: Yeah, he's around here somewhere. Is this his wife?

FEMALE CALLER: Yeah, I'm trying to find out if he is around there.

PAPD JOHN O'DONNELL: No, everything's fine, he's okay.

FEMALE CALLER: Okay, so he's fine. Okay, thank you.

PAPD JOHN O'DONNELL: All right, bye. (PAUSE)

(PHONE RINGING)

PAPD JOHN O'DONNELL: Port Authority Police.

JOAN CULLINS: Yeah, hi, this is Joan Cullins, did (Inaudible) to the city?

PAPD JOHN O'DONNELL: Yes.

JOAN CULLINS: Okay.

PAPD JOHN O'DONNELL: Yeah, he's fine.

JOAN CULLINS: Okay.

PAPD JOHN O'DONNELL: All right?

JOAN CULLINS: Bye.

PAPD JOHN O'DONNELL: Bye-bye. (PAUSE)

(PHONE RINGING)

PAPD JOHN O'DONNELL: Port Authority Police.

PAPD CARL MOORE: Hey, who's that.

PAPD JOHN O'DONNELL: O'Donnell.

PAPD CARL MOORE: O'Donnell, how are you doing?

PAPD JOHN O'DONNELL: Who's this?"

PAPD CARL MOORE: Moore.

PAPD JOHN O'DONNELL: What's up, Carl?

PAPD CARL MOORE: Are they calling anybody in?

PAPD JOHN O'DONNELL: They're calling everybody in.

PAPD CARL MOORE: So I'll be in.

PAPD JOHN O'DONNELL: Okay.

PAPD CARL MOORE: All right, go to Journal Square?

PAPD JOHN O'DONNELL: I guess so. You might as well come here first.

PAPD CARL MOORE: Okay.

PAPD JOHN O'DONNELL: I don't think we have any supervisors here right now anyway.

PAPD CARL MOORE: Okay.

PAPD JOHN O'DONNELL: Over in Holland.

PAPD CARL MOORE: Okay, bye.

PAPD JOHN O'DONNELL: All right, come in here first.

PAPD CARL MOORE: All right. (PAUSE)

(PHONE RINGING)

PAPD JOHN O'DONNELL: Port Authority Police.

PAPD MALE: Port Authority Police, who's this?

PAPD JOHN O'DONNELL: John.

PAPD MALE: I'm in Staten Island. Should I try to get to the Trade Center, or try to come to

the Port Authority?

PAPD JOHN O'DONNELL: No, they want everybody to come here first.

PAPD MALE: You got it.

PAPD JOHN O'DONNELL: Everybody is already over there, we got no supervisors here.

PAPD MALE: All right, I'm on my way.

PAPD JOHN O'DONNELL: Okay.

PAPD MALE: Bye. (PAUSE)

(PHONE RINGING)

PAPD JOHN O'DONNELL: Port Authority Police, O'Donnell.

LIEUTENANT RAYMOND: O'Donnell, this is Lieutenant Raymond, here.

PAPD JOHN O'DONNELL: Yes, sir.

LIEUTENANT RAYMOND: (Inaudible) hear anything about the trade center? Because my

wife works over there.

PAPD JOHN O'DONNELL: I don't have any information other than there was ... that it's some

sort of explosion. There's a possibility ... they talked about a plane that might have hit it.

LIEUTENANT RAYMOND: There's two planes. One I saw on the news, the south tower.

PAPD JOHN O'DONNELL: Right. But we don't have any other information, other than that.

LIEUTENANT RAYMOND: Nothing else?

PAPD JOHN O'DONNELL: No, I wish I could tell you more, sir.

LIEUTENANT RAYMOND: Yeah, I wish so too.

PAPD JOHN O'DONNELL: I mean, if you want to check back with ... but where does she

work?

LIEUTENANT RAYMOND: She's like the 61st floor, Tower One.

PAPD JOHN O'DONNELL: Right.

LIEUTENANT RAYMOND: But it looks like it's higher than that.

PAPD JOHN O'DONNELL: Yeah. But I have no ... at this point, I have no idea. There was a

report of a collapse on the B-4 level too.

LIEUTENANT RAYMOND: Really?

PAPD JOHN O'DONNELL: Yeah. So I really don't know what's going on.

LIEUTENANT RAYMOND: All right, (Inaudible).

PAPD JOHN O'DONNELL: Okay. (LONG PAUSE)

(PHONE RINGING)

PAPD JOHN O'DONNELL: Port Authority Police, O'Donnell.

PAPD MALE: Johnny, what do we do?

PAPD JOHN O'DONNELL: Come in.

PAPD MALE: I just woke up.

PAPD JOHN O'DONNELL: All right, get in as soon as you can.

PAPD MALE: I'm on my way.

PAPD JOHN O'DONNELL: All right. (PAUSE)

PAPD JOHN O'DONNELL: Port Authority Police, O'Donnell.

CALLER: Hello, I talked to (Inaudible) (Crying) World Trade ... how can I ... how can I find

out?

PAPD JOHN O'DONNELL: Sir, we ... we don't know anything right now. We only know as much as you know at this point.

CALLER: (Inaudible) make a call?

PAPD JOHN O'DONNELL: No, sir, because we have no idea what has happened at this point.

CALLER: Thank you. (PAUSE)

(PHONE RINGING)

PAPD JOHN O'DONNELL: Port Authority Police, O'Donnell.

PAPD OFFICER: Hey, John, it's Conner.

PAPD JOHN O'DONNELL: Yeah.

PAPD OFFICER: They calling people in?

PAPD JOHN O'DONNELL: Yeah, anybody that can get here, come in. Come to Journal

Square.

PAPD OFFICER: I'll be (Inaudible).

PAPD JOHN O'DONNELL: Whatever, all right. Anybody.

PAPD OFFICER: All right. (PAUSE)

(PHONE RINGING) (49:49)

PAPD JOHN O'DONNELL: Port Authority Police, O'Donnell.

PAPD MARTY: John, it's Marty. Give Eric a holler, I sent him to the Marriott to check on

those injuries. Give him a holler, and see if he's picking up.

PAPD JOHN O'DONNELL: Who, Bolger?

PAPD MARTY: Eric and Lemagne (Overlap)

PAPD JOHN O'DONNELL: I thought he was standing by at Exchange.

PAPD MARTY: No, Eric's over here with Lemagne. I (Inaudible), pick him up. Just give him

a holler, because (Overlap)

PAPD JOHN O'DONNELL: All right. (Overlap)

PAPD MARTY: All right?

PAPD JOHN O'DONNELL: Okay. (PAUSE)

(52:30)

PAPD JOHN O'DONNELL: Police desk.

MALE - PATH: Hi, this is the (Inaudible) desk. (Inaudible) services, Newark as far as Journal

Square, at Journal Square, we are going up to 33rd Street.

PAPD JOHN O'DONNELL: Okay.

MALE - PATH: No service to Exchange Place or the World Trade, naturally. Okay, so ...

PAPD JOHN O'DONNELL: All right.

MALE - PATH: ... anyone that wants to go to Exchange, has to go to globe (Inaudible).

PAPD JOHN O'DONNELL: Is there anybody in Exchange waiting to get out?

MALE - PATH: Nope, the station has been closed down.

PAPD JOHN O'DONNELL: Closed, okay. All right.

MALE - PATH: It looks like the World Trade is (Inaudible).

PAPD JOHN O'DONNELL: The World Trade is closed, Exchange is closed.

MALE - PATH: That's correct.

PAPD JOHN O'DONNELL: Only service to 33rd.

MALE - PATH: That's correct.

PAPD JOHN O'DONNELL: Okay, all right, thank you. (PAUSE)

(PHONE RINGING)

OFFICER'S WIFE: Hello?

PAPD JOHN O'DONNELL: Hello.

OFFICER'S WIFE: Hi, honey.

PAPD JOHN O'DONNELL: Hi.

OFFICER'S WIFE: Oh, it's good to hear your voice. Okay, I'm just saying (Overlap)

PAPD JOHN O'DONNELL: Yeah, I gotta ... I gotta go.

OFFICER'S WIFE: Are you going to stay at Journal Square?

PAPD JOHN O'DONNELL: As far as I know, yeah.

OFFICER'S WIFE: Okay, that's fine, I just wanted to hear.

PAPD JOHN O'DONNELL: All right.

OFFICER'S WIFE: Okay, bye honey. (PAUSE)

(PHONE RINGING) (56:20)

PAPD JOHN O'DONNELL: Port Authority Police, O'Donnell.

FEMALE CALLER: I'm out on the road here, (Inaudible) to the World Trade Center.

PAPD JOHN O'DONNELL: Well, I can't give you any information, ma'am, we have no idea where anybody could be, might be, or any possibilities right now. We are right in the middle of everything. We have no reports on anything right now.

FEMALE CALLER: Okay, thank you.

PAPD JOHN O'DONNELL: Okay. (PAUSE)

(PHONE RINGING) (56:50)

PAPD JOHN O'DONNELL: Police desk, O'Donnell.

MRS. STUART: Hi, good morning. This is Mrs. Stuart. I just wanted to know if my husband has been (Overlap)

PAPD JOHN O'DONNELL: He's fine.

MRS. STUART: Stuart (Overlap)

PAPD JOHN O'DONNELL: Yeah, he's okay. He's fine.

MRS. STUART: Really (Inaudible)?

PAPD JOHN O'DONNELL: I spoke to him on the radio before. He's over at the World Trade Center, but I spoke to him, he's fine.

MRS. STUART: He was stationed there this morning?

PAPD JOHN O'DONNELL: Yes. He's ... he's fine, okay?

MRS. STUART: Okay.

PAPD JOHN O'DONNELL: I already spoke to him on the radio, he was helping someone.

MRS. STUART: Okay, thank you.

PAPD JOHN O'DONNELL: Okay.

MRS. STUART: Bye-bye.

PAPD JOHN O'DONNELL: Bye. (PAUSE)

(PHONE RINGING)

PAPD JOHN O'DONNELL: Port Authority Police, O'Donnell.

PAPD JIMMY: Yeah, it's (inaudible), sorry to bother you.

PAPD JOHN O'DONNELL: Nah.

PAPD JIMMY: Do they want everybody to come in?

PAPD JOHN O'DONNELL: Everybody that can get in here, Jimmy, come on in.

PAPD JIMMY: Okay.

PAPD JOHN O'DONNELL: All right?

PAPD JIMMY: Bye.

PAPD JOHN O'DONNELL: Bye.

(PHONE RINGING)

PAPD JOHN O'DONNELL: Police Desk, O'Donnell.

BRIAN - SUPERINTENDENT STRUCTURES: O'Donnell, Brian (Inaudible), this is the superintendent of (Inaudible) Structures, upstairs. I got two vans at (Inaudible) right now.

PAPD JOHN O'DONNELL: Okay, I'm sending a guy out there to stand by with them.

Do you want (Overlap)

BRIAN - SUPERINTENDENT STRUCTURES: (Overlap) Just take the keys or ...?

PAPD JOHN O'DONNELL: No, no, we'll ... wait, let me find out from the sergeant.

(PAUSE) (To personnel at the station) What do you want them to do with the vehicles

they're giving us? Are we taking over the vehicles? Or are we going to use their personnel to drive them?

SERGEANT: Have the personnel stand by, I mean, so that they can go over and come back.

PAPD JOHN O'DONNELL: Yeah, have your guys stand by with the vehicles.

BRIAN - SUPERINTENDENT STRUCTURES: Okay, got it.

PAPD JOHN O'DONNELL: We need to load them up and send them over so that they can come back.

BRIAN - SUPERINTENDENT STRUCTURES: Got it.

PAPD JOHN O'DONNELL: All right?

BRIAN - SUPERINTENDENT STRUCTURES: Okay.

PAPD JOHN O'DONNELL: Thank you.

BRIAN - SUPERINTENDENT STRUCTURES: Bye-bye. (PAUSE)

(PHONE RINGING)

PAPD JOHN O'DONNELL: Port Authority Police.

PAPD LARRY: Hey, what's up? This is Larry.

PAPD JOHN O'DONNELL: Yeah?

PAPD LARRY: My roommate just told me to come in?

PAPD JOHN O'DONNELL: Come in. If you can get here, come in.

PAPD LARRY: Okay, all right, all the subways are shut and everything?

PAPD JOHN O'DONNELL: I don't know what ... no, if you get to 33rd Street, the train is running.

PAPD LARRY: Okay.

PAPD JOHN O'DONNELL: All right, so you can get to the square from there.

PAPD LARRY: Okay, I got to get to 33rd. All right, I'll be there as soon as I can.

PAPD JOHN O'DONNELL: Okay.

PAPD LARRY: All right. Bye. (PAUSE)

(PHONE RINGING) (1:01:30)

PAPD JOHN O'DONNELL: Port Authority Police, O'Donnell.

STATE TROOPER - MARK: Hi, how are you doing? This is (Inaudible) State

Trooper.

PAPD JOHN O'DONNELL: Yeah.

STATE TROOPER - MARK: I was wondering if you could do a check on SPEN 1 and

2, and make sure that you guys are operational.

PAPD JOHN O'DONNELL: On SPEN 1 and 2?

STATE TROOPER - MARK: Yeah.

PAPD JOHN O'DONNELL: Radio check for police on SPEN 1.

STATE TROOPER - MARK: Did you pick me up?

PAPD JOHN O'DONNELL: Uh, I don't have it, I don't get it.

STATE TROOPER - MARK: Oh, you don't have it.

PAPD JOHN O'DONNELL: No.

STATE TROOPER - MARK: All right. Okay, I'll get it.

PAPD JOHN O'DONNELL: Okay, all right, thanks.

STATE TROOPER - MARK: If there is a problem give me a call back, 7071.

PAPD JOHN O'DONNELL: All right.

STATE TROOPER - MARK: Thanks. (PAUSE)

(PHONE RINGING)

PAPD JOHN O'DONNELL: Police Desk, O'Donnell.

MALE CALLER: Yes, sir, could you tell me if the trains are running even though there

is a terrorist attack on the World Trade?

PAPD JOHN O'DONNELL: The trains are running from Journal Square to 33rd Street,

that's all I have right now.

MALE CALLER: Thank you. (PAUSE)

(PHONE RINGING)

PAPD JOHN O'DONNELL: Port Authority Police, O'Donnell.

PAPD BILL YOUNG: John, Bill Young.

PAPD JOHN O'DONNELL: Yeah.

PAPD BILL YOUNG: Listen, I need the number to the heliport.

PAPD JOHN O'DONNELL: Where are you?

PAPD BILL YOUNG: I'm on a ferry. I'm on active duty, I'm en route to the trade center.

PAPD JOHN O'DONNELL: You're not going to get in there, it's ...

PAPD BILL YOUNG: I'm on a boat.. I'm going to a hotel to set up a press room.

PAPD JOHN O'DONNELL: Uh ... heliport, hang on. Which one are you talking ...

downtown heliport?

PAPD BILL YOUNG: Yeah, our heliport, Wall Street.

PAPD JOHN O'DONNELL: Heliport operations, 248-7240.

PAPD BILL YOUNG: 7240 ... can you switch me?

PAPD JOHN O'DONNELL: I'll try, hang on. (DIAL TONE) Billy?

PAPD BILL YOUNG: Yes.

PAPD JOHN O'DONNELL: Hold on, I gotta try it again.

PAPD BILL YOUNG: Thank you. (DIAL TONE) (BUSY SIGNAL)

PAPD JOHN O'DONNELL: Billy, it's busy.

PAPD BILL YOUNG: All right, I'll try, thank you.

PAPD JOHN O'DONNELL: All right.

PAPD BILL YOUNG: Bye. (PAUSE)

(PHONE RINGING) (1:30:46)

PAPD JOHN O'DONNELL: Port Authority Police, O'Donnell. (HANG UP) (PAUSE)

(INAUDIBLE SECTION - CONVERSATION AT STATION)

PAPD JOHN O'DONNELL: Port Authority Police, O'Donnell.

PAPD BRIAN PORTER: Yeah, Porter.

PAPD JOHN O'DONNELL: What's up?

PAPD BRIAN PORTER: Nothing, is Cashin there?

PAPD JOHN O'DONNELL: Yeah, he's right here.

PAPD BRIAN PORTER: Let me talk to him.

PAPD JOHN O'DONNELL: Hold on.

PAPD TOMMY CASHIN: Port Authority Police, Cashin.

PAPD BRIAN PORTER: Hi, Tom.

PAPD TOMMY CASHIN: Hi, Brian.

PAPD BRIAN PORTER: How you doing?

PAPD TOMMY CASHIN: All right, they mobilized everybody. I don't know if you're

sick or not.

PAPD BRIAN PORTER: I'm on IOD.

PAPD TOMMY CASHIN: I didn't know that, I didn't realize that.

PAPD BRIAN PORTER: Does that mean I'm still supposed to come?

PAPD TOMMY CASHIN: No. no. No.

PAPD BRIAN PORTER: No?

PAPD TOMMY CASHIN: No, Brian, I'm sorry. I thought you were back to work, I

didn't know.

PAPD BRIAN PORTER: So what's up? So I don't come in, then.

PAPD TOMMY CASHIN: No ... okay? That's what I got.

PAPD BRIAN PORTER: All right.

PAPD TOMMY CASHIN: All right.

PAPD BRIAN PORTER: Thanks, brother.

PAPD TOMMY CASHIN: Bye. (PAUSE)

(PHONE RINGING)

PAPD JOHN O'DONNELL: Port Authority Police, O'Donnell.

DEANNA: Is Eric available?

PAPD JOHN O'DONNELL: Bolger.

DEANNA: Yes.

PAPD JOHN O'DONNELL: No, he's not. We have an emergency right now, nobody is

available.

DEANNA: Okay, (Inaudible) the World Trade Center?

PAPD JOHN O'DONNELL: Yeah.

DEANNA: Okay, I'll talk to him later. It's Deanna, bye-bye. (PAUSE)

(PHONE RINGING)

PAPD TOMMY CASHIN: Port Authority Police, Cashin.

FEMALE CALLER: Are the PATH trains operating?

PAPD TOMMY CASHIN: No, ma'am, they're not. Goodbye. (PAUSE)

(PHONE RINGING)

PAPD TOMMY CASHIN: Port Authority Police, Cashin.

FEMALE CALLER: Yes, I'm trying to find out, is the PATH train running?

PAPD TOMMY CASHIN: No, we have no service right now.

FEMALE CALLER: No service, but what about the people that are on it right now?

PAPD TOMMY CASHIN: Well, ma'am, I don't know about that, I'll tell you what, I could switch you over to communications, all right?

FEMALE CALLER: All right, well, that's (Overlap) (DIAL TONE)

PAPD TOMMY CASHIN: Okay, hold on. (PAUSE)

(PHONE RINGING)

PAPD TOMMY CASHIN: Port Authority Police, Cashin.

CAPTAIN SAVAR: How are you, this is Captain Savar. I've been trying to get in

touch with (Inaudible). Do you have any way of getting in touch with him?

PAPD TOMMY CASHIN: No, I don't have any way of getting in touch with him, except through the Holland Tunnel.

CAPTAIN SAVAR: Yeah, I've been calling over there, the phone numbers are down.

PAPD TOMMY CASHIN: Yeah, I can't get through there either. Their phone numbers are down. I don't have anything further on it. Everybody is responding over. The only thing I could say, if I hear from him, I'll tell him to call you.

CAPTAIN SAVAR: Yes, if you would, it's Captain Savar, just tell him to call home.

PAPD TOMMY CASHIN: Okay.

CAPTAIN SAVAR: All right, thank you.

PAPD TOMMY CASHIN: All right, bye.

CAPTAIN SAVAR: Bye-bye. (PAUSE)

(PHONE RINGING)

PAPD CALLAHAN: Port Authority Police, Callahan.

PAPD TOMMY CASHIN: Yeah, Callahan, this is Cashin downstairs. We got a report

the other tower (Overlap)

PAPD CALLAHAN: (Overlap) Went down.

PAPD TOMMY CASHIN: All right.

PAPD CALLAHAN: All right.

PAPD TOMMY CASHIN: Thanks. (PAUSE)

(VARIOUS TELEPHONE NOISES)

(CONVERSATION IN OFFICE/INAUDIBLE RADIO TRANSMISSIONS)

WOMAN: Hello?

PAPD TOMMY CASHIN: Hi, hold on.

WOMAN: Yes?

PAPD TOMMY CASHIN: Hey, mom, Tommy.

WOMAN: Hi, Tommy.

PAPD TOMMY CASHIN: Hi, how are you. You talked to Paul?

WOMAN: Oh, terrible.

PAPD TOMMY CASHIN: Did she talk to Paul?

WOMAN: I didn't get her to talk to him.

PAPD TOMMY CASHIN: Okay.

WOMAN: Why, did you talk to her?

PAPD TOMMY CASHIN: I can't get through to her. Please call him and tell him I'm
