POLICE DESK - KELLIHER: Hello, police desk.

PO SCHILLIZZI: SCHILLIZZI. We are responding down with all units at the

World Trade. (Inaudible), bye.

(PHONE RINGING/DIAL TONES) (OFFICE CONVERSATION/COMMOTION)

POLICE DESK - KELLIHER: Hello? (DIAL TONE) (PHONE RINGING)

(PAUSE) (PHONE RINGING - LONG PAUSE - NO DIALOGUE)

POLICE DESK: DO YOU WANT ME TO CALL THE LINCOLN THE HOLLAND?

(LONG PAUSE - RINGING)

PORT AUTHORITY POLICE: Port Authority Police.

HECTOR MORRIS: This is Hector Morris, could you please (Overlap)

PORT AUTHORITY POLICE: Stand by. Stand by for Sergeant Rowe. (LONG

PAUSE) (PHONE RINGING) Port Authority Police.

MALE: Hi (Overlap)

PORT AUTHORITY POLICE: Stand by for Sergeant Rowe.

MALE: Yeah, I ...

PORT AUTHORITY POLICE: Hold on.

MALE: All right. (LONG PAUSE) (PHONE RINGING)

POLICE DESK SERGEANT MARIANO: Sergeant Murranio.

JEFF BECKLE: Hey, John, Jeff Beckle.

POLICE DESK SERGEANT MARIANO: Hey, Jeff.

JEFF BECKLE: I just saw what happened. You need bodies?

POLICE DESK SERGEANT MARIANO: We need bodies. Where are you?

JEFF BECKLE: I'm home. I could just jump in the car, and I'll get (Overlap)

just wanted to let you know.

POLICE DESK SERGEANT MARIANO: Okay, all right. Thanks.

CONTROL DESK: All right.

POLICE DESK SERGEANT MARIANO: Sergeant MARIANO.

GENE: John, Gene. You want me to head in now?

POLICE DESK SERGEANT MARIANO: Yeah, Gene, you're doing afternoons,

right?

GENE: Yeah.

POLICE DESK SERGEANT MARIANO: Yeah, come on in, brother.

GENE: Okay.

POLICE DESK SERGEANT MARIANO: All right, bye.

(PHONE RINGING)

POLICE DESK SERGEANT MARIANO: Sergeant MARIANO.

MALE: You want to put something over SPEN? Another plane went into the building. Did you see it?

POLICE DESK SERGEANT MARIANO: No!

MALE: Another plane just went into One World Trade Center. It's got to be terrorist attack. The one plane went in two, John, and another one just went in one. And they just exploded.

POLICE DESK SERGEANT MARIANO: Oh, my God.

MALE: Put it over SPEN, all right?

POLICE DESK SERGEANT MARIANO: Okay.

MALE: Bye.

POLICE DESK SERGEANT MARIANO: Bye.

(PHONE RINGING) (PAUSE)

FEMALE OPERATOR: This is (Inaudible).

MALE: This is (Inaudible).

FEMALE OPERATOR: Yeah, hi.

MALE: What are they going to do, I'm on leave, but can I come in?

FEMALE OPERATOR: All right, hold on a second. (DIAL TONE) I just talked

to ... now, no, you can't come back, we have to talk to you later.

MALE: All right, thanks.

FEMALE OPERATOR: Bye.

(PHONE RINGING) (PAUSE) (PHONE RINGING)

PORT AUTHORITY POLICE: Port Authority Police.

CAPTAIN: Hi, Mary, this is Captain (Inaudible).

PORT AUTHORITY POLICE: Captain, yeah, hold on.

CAPTAIN: I want to know (Overlap)

PORT AUTHORITY POLICE: You want to know ... hold on. (PAUSE)

(PHONE RINGING)

POLICE DESK SERGEANT MARIANO: Sergeant MARIANO.

SERGEANT ORIVO: Sergeant MARIANO, Sergeant Orivo. Are they starting

mobilizing people?

POLICE DESK SERGEANT MARIANO: Everybody's been mobilized. This may be a terrorist attack, Benny.

SERGEANT ORIVO: All right, see, I don't want to go down after another (Inaudible).

POLICE DESK SERGEANT MARIANO: All right.

SERGEANT ORIVO: Do they need any people from us?

POLICE DESK SERGEANT MARIANO: At this time, we are just doing evacuations.

SERGEANT ORIVO: All right, just so you'll know, I'm not sending any canine people or bomb until I hear from you.

POLICE DESK SERGEANT MARIANO: Okay.

SERGEANT ORIVO: And (Inaudible) garble what's the (Inaudible).

POLICE DESK SERGEANT MARIANO: I got you.

SERGEANT ORIVO: All right. Bye.

POLICE DESK SERGEANT MARIANO: Sergeant MARIANO. (24:52)

PAT HOEY: Sergeant, this is Pat Hoey, I'm with the Port Authority. I'm in the trade center.

POLICE DESK SERGEANT MARIANO: What's up?

PAT HOEY: I'm on the 64th floor.

POLICE DESK SERGEANT MARIANO: Okay.

PAT HOEY: In Tower One.

POLICE DESK SERGEANT MARIANO: All right.

PAT HOEY: I've got about 20 people here with me.

POLICE DESK SERGEANT MARIANO: Okay.

PAT HOEY: What do you suggest? (LOUD COMMOTION) Staying tight?

POLICE DESK SERGEANT MARIANO: Stand tight. Is there a fire right there

where you are?

PAT HOEY: No, there is a little bit of smoke on the floor.

POLICE DESK SERGEANT MARIANO: It looks like there is also an explosion

POLICE DESK SERGEANT MARIANO: So be careful. Stay near the

POLICE DESK SERGEANT MARIANO: I got you.

PAT HOEY: Thank you.

POLICE DESK SERGEANT MARIANO: All right, bye. (25:35)

POLICE DESK SERGEANT MARIANO: Hello? Sergeant MARIANO.

MARK: John, Mark.

POLICE DESK SERGEANT MARIANO: Hi, Mark.

MARK: What's up?

POLICE DESK SERGEANT MARIANO: Where are you, Mark?

MARK: I'm at the bridge.

POLICE DESK SERGEANT MARIANO: All right, all accesses [sic] to New

York, shut down.

MARK: What do you mean, shut down?

POLICE DESK SERGEANT MARIANO: Shut down. All accesses to New York,

into the city.

MARK: Shut down the bridge?

POLICE DESK SERGEANT MARIANO: That's correct.

MARK: Okay.

POLICE DESK SERGEANT MARIANO: All right?

MARK: All right, bye.

POLICE DESK SERGEANT MARIANO: Sergeant MARIANO.

FEMALE: Linda (Inaudible).

POLICE DESK SERGEANT MARIANO: Stand by, she's okay.

FEMALE: I'll talk to her later.

POLICE DESK SERGEANT MARIANO: All right, okay.

(DIAL TONE) (LOUD COMMOTION)

POLICE DESK SERGEANT MARIANO: Sergeant MARIANO. (DIAL TONE)

(PHONE RINGING)

PA FEMALE: Port Authority.

POLICE DESK SERGEANT MARIANO: Hey, it's MARIANO.

PA FEMALE: What (Inaudible)?

POLICE DESK SERGEANT MARIANO: Tell the boss to shut down all accesses to New York City.

PA FEMALE: (Inaudible) (PAUSE) (BACKGROUND NOISE)

(PHONE RINGING)

POLICE DESK SERGEANT MARIANO: Sergeant MARIANO.

FEMALE: We need a marked car to go to (Inaudible) and pick him up and bring him down to the Trade Center. The place is hysterical. We've got nobody here. And I have direct (Inaudible).

POLICE DESK SERGEANT MARIANO: I can't even begin to get through to where I could find a marked car.

FEMALE: I tried the bus terminal and the tunnel, and I don't think anybody even answered at the tunnel.

POLICE DESK SERGEANT MARIANO: We sent everybody we could over to the Trade Center to help.

FEMALE: Yeah. (Inaudible) talk to (Inaudible), he's beside himself.

POLICE DESK SERGEANT MARIANO: Sure.

FEMALE: I don't know who else we can get to bring him.

POLICE DESK SERGEANT MARIANO: All right, I'll ponder it in my brain, and see what I can do.

FEMALE: All right, because anybody from here will never get uptown.

POLICE DESK SERGEANT MARIANO: No, you're never going to get up there.

FEMALE: All right.

POLICE DESK SERGEANT MARIANO: Okay? Bye. (PAUSE)

POLICE DESK SERGEANT MARIANO: Sergeant MARIANO.

POLICE OFFICER: Hey, Sarge, do you know the channel that everybody is

going to go through?

POLICE DESK SERGEANT MARIANO: We don't have ... in fact, my radio just

went down.

POLICE OFFICER: Your radios went down?

POLICE DESK SERGEANT MARIANO: Just went down.

POLICE OFFICER: Okay, and is there a Command Post ...

POLICE DESK SERGEANT MARIANO: We sent the guy over with the

Command Post, but I don't know what ... how he's doing in traffic, I don't know

what he is going to set up.

POLICE OFFICER: Okay, no problem.

POLICE DESK SERGEANT MARIANO: All right, bye. (PAUSE)

POLICE DESK SERGEANT MARIANO: Sergeant MARIANO.

POLICE OFFICER: Sergeant, do you want more guys in? This is (Inaudible).

POLICE DESK SERGEANT MARIANO: Where are you?

POLICE OFFICER: I'm home.

POLICE DESK SERGEANT MARIANO: You're home?

POLICE OFFICER: Yes.

POLICE DESK SERGEANT MARIANO: Go into your command.

POLICE OFFICER: Okay.

POLICE DESK SERGEANT MARIANO: All right? Bye. (PAUSE)

POLICE DESK SERGEANT MARIANO: Sergeant MARIANO.

NBC NEWSMAN: It's NBC News. Can you put anybody on the air?

NBC NEWSMAN: Is this the right number to call when you will be ready?

POLICE DESK SERGEANT MARIANO: If I can get a public affairs person

here, I probably could get somebody, but I don't know where they are. They

were in that building, exactly where it was hit.

NBC NEWSMAN: Oh.

POLICE DESK SERGEANT MARIANO: I can tell you this much, both buildings

have been hit.

NBC NEWSMAN: Yeah, we've seen that. Is there anybody that can go on the

phone or ...

POLICE DESK SERGEANT MARIANO: No, we don't know anything, what

happened, yet.

NBC NEWSMAN: Thank you very much.

POLICE DESK SERGEANT MARIANO: All right.

NBC NEWSMAN: Appreciate it. (MUSIC)

POLICE DESK SERGEANT MARIANO: Sergeant MARIANO. (PHONE RINGING)

POLICE DESK SERGEANT MARIANO: Sergeant MARIANO.

CHIEF HALL: Hey, John, this is Chief Hall.

POLICE DESK SERGEANT MARIANO: Hi, Chief.

CHIEF HALL: What are you sending me?

POLICE DESK SERGEANT MARIANO: We mobilized everybody.

CHIEF HALL: Right.

POLICE DESK SERGEANT MARIANO: Everybody from every command, they're stripping their commands and sending them down to you.

CHIEF HALL: Where's the Command Post?

POLICE DESK SERGEANT MARIANO: Acardi is on the way. As soon as he comes up on the air, if I ... I don't even think I have an air.

CHIEF HALL: Okay, is the Holland Tunnel closed to New York?

POLICE DESK SERGEANT MARIANO: The Holland Tunnel is closed to New York.

CHIEF HALL: All right.

POLICE DESK SERGEANT MARIANO: Okay?

CHIEF HALL: I don't know where the director is. I brought him with me here, I lost him. So he is somewhere in the fucking building.

POLICE DESK SERGEANT MARIANO: I got you.

CHIEF HALL: All right, if you need me, you call me on the cell phone.

POLICE DESK SERGEANT MARIANO: I got you.

CHIEF HALL: All right, bye.

POLICE DESK SERGEANT MARIANO: Bye. (PAUSE)

(DIAL TONE) (LONG PAUSE) (PHONE RINGING)

POLICE DESK SERGEANT MARIANO: Sergeant MARIANO.

POLICE OFFICER: John, on whose authority are we closing all these bridges?

POLICE DESK SERGEANT MARIANO: Chief Hall.

POLICE OFFICER: Chief Hall. All right.

POLICE DESK SERGEANT MARIANO: Okay, bye. (PAUSE)

(PHONE RINGING)

PORT AUTHORITY POLICE: Port Authority, Police Officer ZAPULLA.

NEDIA: Hi, Vinnie, Nedia.

PORT AUTHORITY POLICE: Yeah.

NEDIA: You guys' ECR going through to (Inaudible)?

PORT AUTHORITY POLICE: Well, we're trying. We've got as many people as

we can.

NEDIA: All right.

PORT AUTHORITY POLICE: Bring everybody in, bring them all in.

NEDIA: Okay.

PORT AUTHORITY POLICE: Bye.

NEDIA: No, wait.

PORT AUTHORITY POLICE: I need you to do ... (Overlap) What, what?

NEDIA: Could you have Molesky, I think that's ... he's coming at the Lincoln.

PORT AUTHORITY POLICE: Whoever is available is available, okay? It's a

mess.

NEDIA: All right. (Overlap)

PORT AUTHORITY POLICE: Bye.

NEDIA: Bye-bye.

PORT AUTHORITY POLICE: Port Authority, Police Officer ZAPULLAZA.

BOBBY MORRELL: Vinnie, Bobby Morrell.

PORT AUTHORITY POLICE: Hey, Bob, where are you?

BOBBY MORRELL: I'm at home, but I can come in.

PORT AUTHORITY POLICE: Go to the Trade Center.

BOBBY MORRELL: All right.

PORT AUTHORITY POLICE: All right?

BOBBY MORRELL: I'm on vacation this week.

PORT AUTHORITY POLICE: Whatever, come in. Do whatever you need, all

right?

BOBBY MORRELL: Got it. Bye.

PORT AUTHORITY POLICE: Port Authority, Police Officer ZAPULLA.

DISPATCH OFFICER: Dispatch here.

PORT AUTHORITY POLICE: Hi, (Inaudible) Dispatch. Okay, what we are going to try ... what we'd like to do is try and get you guys coordinated with New York City, okay?

DISPATCH OFFICER: What's the possible (Inaudible)

PORT AUTHORITY POLICE: Okay, I got North Star right now, I got the ... is the op center?

DISPATCH OFFICER: Yes.

PORT AUTHORITY POLICE: (To station personnel) I have the op center, right now, Eddie.

OFFICER IN STATION: (Inaudible), have we got the op center?

PORT AUTHORITY POLICE: Okay, hang on one second.

(LOUD COMMOTION)

OFFICER IN STATION: Do you have the (Inaudible) resources?

DISPATCH OFFICER: Right.

OFFICER IN STATION: Yeah, we can help you with that.

DISPATCH OFFICER: Okay, that's fine, we'll take that too. We'll take that too.

OFFICER IN STATION: Let me know what you need.

PORT AUTHORITY POLICE: Hang on one second, Eddie. You want to call ... call this number. 212-374-5580.

DISPATCH OFFICER: Right, okay.

PORT AUTHORITY POLICE: And that's where you can get ... that New York City Op, and so you can coordinate them as far as the (Inaudible) okay? And as

far as ambulances are concerned, let me have a call-back number and I'll get right back to you.

DISPATCH OFFICER: Okay, it's 973-972-75-- (Inaudible).

PORT AUTHORITY POLICE: Okay, thank you.

DISPATCH OFFICER: And just call this number and let us know that, otherwise (Inaudible). Call that number after you find out what they need.

PORT AUTHORITY POLICE: Yeah, we need North Star. Absolutely, no doubt about it.

DISPATCH OFFICER: (Inaudible) go?

PORT AUTHORITY POLICE: We're going to try and get the ... we are going to try to find the staging area, that's where we need to go ... we need you to have ... (LOUD COMMOTION)

DISPATCH OFFICER: (Inaudible) where you are.

PORT AUTHORITY POLICE: That would be fine for now. And then you will be contacting New York City ops, they have a staging area as well, something closer.

DISPATCH OFFICER: Okay.

PORT AUTHORITY POLICE: Okay, thank you very much, bye-bye. (PAUSE)

PORT AUTHORITY POLICE: Port Authority, Police Officer ZAPULLA.

(RECORDING) Hello? (PHONE RINGING) (LONG PAUSE) Port Authority,

Police Officer ZAPULLA.

BLOOMBERG TV - MELANIE: Hi, this is Melanie, I'm calling from Bloomberg Television.

PORT AUTHORITY POLICE: Yeah, yeah.

BLOOMBERG TV - MELANIE: Who do you speak to, to ...

PORT AUTHORITY POLICE: Port Authority Police, Officer ZAPULLA.

CONCERNED MAN: Yeah, hi, I have some relatives at the World Trade

Center.

PORT AUTHORITY POLICE: I understand sir, I understand. There is no information at this time, sir.

CONCERNED MAN: Do you know which tower they ...

PORT AUTHORITY POLICE: Sir ... no.

CONCERNED MAN: No tower, terrific. Is it really (Overlap) flew so low ...

PORT AUTHORITY POLICE: Sir, I ... I ... we don't even know ourselves, okay?

We can't even see from where we are at this point, we are still waiting for reports

coming in, okay? I am sorry.

CONCERNED MAN: Okay.

PORT AUTHORITY POLICE: Okay, thank you. (PAUSE)

(PHONE RINGING) (PAUSE)

POLICE DESK SERGEANT MARIANO: Sergeant MARIANO.

BLOOMBERG TV - MELANIE: Hi, MARIANO, this is Melanie Schock, with

Bloomberg Television. Sorry. Listen, really quick question. Do you know where

I can find a list of all the companies located in both the World Trade Centers?

POLICE DESK SERGEANT MARIANO: I don't have that, darling. I don't have

that now.

BLOOMBERG TV - MELANIE: Is there somebody from your department who

can do a folder with that?

POLICE DESK SERGEANT MARIANO: Not right now. I got every cop that I

know of that's in my command over at the World Trade Center right now.

BLOOMBERG TV - MELANIE: Nobody at your location has a folder (Overlap)

POLICE DESK SERGEANT MARIANO: No. No, ma'am.

BLOOMBERG TV - MELANIE: Okay, do you know anybody who we can call

about this? Or is there someone (Overlap)

POLICE DESK SERGEANT MARIANO: No, ma'am. It's too early right now.

BLOOMBERG TV - MELANIE: Okay.

POLICE DESK SERGEANT MARIANO: All right?

BLOOMBERG TV - MELANIE: Thank you. (PAUSE)

POLICE DESK SERGEANT MARIANO: Sergeant MARIANO.

OFFICER MIKE SCOTT: Sergeant, Mike Scott, I need to speak to somebody in

the OC.

POLICE DESK SERGEANT MARIANO: Stand by, Mike. (PAUSE)

(PHONE RINGING)

POLICE DESK SERGEANT MARIANO: Sergeant MARIANO.

POLICE OFFICER GREG: Hey, it's Greg, how are you doing?

POLICE DESK SERGEANT MARIANO: Hey, what's up.

POLICE OFFICER GREG: Listen, (Inaudible) come in today or what?

POLICE DESK SERGEANT MARIANO: I would say get in. Okay?

POLICE OFFICER GREG: So I guess report to command?

POLICE DESK SERGEANT MARIANO: Report to your command.

MR. SHIFTAN: Well, I know that he spoke to the chairman briefly, but then they got cut off.

POLICE DESK SERGEANT MARIANO: Yeah, that's when the second plane went in, and the cell phones went out.

MR. SHIFTAN: Okay, I'm at the legal center. 201, I mean 973-565-5502.

POLICE DESK SERGEANT MARIANO: All right, sir, I'll do my best.

MR. SHIFTAN: Is any of the brass in the building?

POLICE DESK SERGEANT MARIANO: Not in my building, sir. I'm at the central desk. They're all over in the headquarters now.

(PAUSE) (PHONE RINGING)

POLICE DESK SERGEANT MARIANO: Sergeant MARIANO.

PATH - TOM CASHIN: Sergeant MARIANO, this is Cashin, down at PATH.

POLICE DESK SERGEANT MARIANO: What's up, Tom? (51:42)

PATH - TOM CASHIN: We have a report over the radio from New York City, that there is a third plane on the way.

POLICE DESK SERGEANT MARIANO: Yeah, we heard that too. I don't know anything other than that.

PATH - TOM CASHIN: All right.

POLICE DESK SERGEANT MARIANO: Military is aware of that, they're the ones that told us.

PATH - TOM CASHIN: Okay, all right.

POLICE DESK SERGEANT MARIANO: Okay?

PATH - TOM CASHIN: All right, thank you.

POLICE DESK SERGEANT MARIANO: All right, bye. (PAUSE)

(PHONE RINGING)

INSPECTOR: (Inaudible), John.

POLICE DESK SERGEANT MARIANO: Sergeant MARIANO.

INSPECTOR: John, Inspector Gurilian, from the DOC.

POLICE DESK SERGEANT MARIANO: All right.

INSPECTOR: Got any word on any of the closings for the tunnels, bridges, anything like that?

POLICE DESK SERGEANT MARIANO: All inbound is closed. All of them.

INSPECTOR: All inbound ... all inbound to New York?

POLICE DESK SERGEANT MARIANO: Right.

INSPECTOR: Every bridge? (52:37)

POLICE DESK SERGEANT MARIANO: Every bridge.

INSPECTOR: And tunnel.

POLICE DESK SERGEANT MARIANO: Right, yes, sir.

INSPECTOR: All right, anything else you got on closure? (LOUD

COMMOTION) Are you getting bombarded with phone calls up there?

POLICE DESK SERGEANT MARIANO: Actually, I am. But I'm just hearing

now that there is another plane on the way in.

INSPECTOR: Really?

POLICE DESK SERGEANT MARIANO: Yeah.

INSPECTOR: Where did they get that from.

POLICE DESK SERGEANT MARIANO: New York City put it over the air.

INSPECTOR: They did?

POLICE DESK SERGEANT MARIANO: Yeah.

INSPECTOR: All right. Thanks, John.

POLICE DESK SERGEANT MARIANO: All right.

INSPECTOR: We're going to have to keep an open line, I think, with this at

some point, but probably ...

POLICE DESK SERGEANT MARIANO: We have your number. You're

downstairs, right?

INSPECTOR: Yeah.

POLICE DESK SERGEANT MARIANO: Okay.

INSPECTOR: All right, but we should stay in the same frequency (Overlap)

POLICE DESK SERGEANT MARIANO: All right, bye. (PAUSE) (53:08)

(PHONE RINGING) (53:47)

POLICE DESK SERGEANT MARIANO: MARIANO. Hello? Sergeant MARIANO.

SHERIFF ESSEX COUNTY: John, this is Sheriff Vatour, from Essex County.

POLICE DESK SERGEANT MARIANO: What can I do for you?

SHERIFF ESSEX COUNTY: Is Mr. Marone available? Of course not.

POLICE DESK SERGEANT MARIANO: Of course not. He's over in the city, and his cell ... all the cell phones are out.

SHERIFF ESSEX COUNTY: Okay, all right. Do me a favor. You let him know that we're here, and if he needs anything, let us know.

POLICE DESK SERGEANT MARIANO: My radios are down.

POLICE OFFICER: Okay.

POLICE DESK SERGEANT MARIANO: So I have nobody to call. If they're not on fire ...

POLICE OFFICER: They said smoke is coming into the offices.

POLICE DESK SERGEANT MARIANO: All right. I think they should hit the stairwells, and get the heck out of there.

POLICE OFFICER: All right, so who ... who can ... is there someone that can give them an evac- ... a Command Center or something?

POLICE DESK SERGEANT MARIANO: There is no Command Center as yet.

We've got the command bus going over there now.

POLICE OFFICER: Okay. Well, I don't want to tell (Inaudible).

POLICE DESK SERGEANT MARIANO: He's on 64, and I couldn't even tell you where the fire is.

POLICE OFFICER: Okay.

POLICE DESK SERGEANT MARIANO: The fire looks to me as if ... like it's above him.

POLICE OFFICER: Well, it looks to me like it's above him.

POLICE DESK SERGEANT MARIANO: I would tell him to get out of there.

POLICE OFFICER: Okay.

POLICE DESK SERGEANT MARIANO: Get out of there, and go down the stairwell.

POLICE OFFICER: Okay.

POLICE DESK SERGEANT MARIANO: All right?

POLICE OFFICER: Okay.

POLICE DESK SERGEANT MARIANO: Okay?

POLICE OFFICER: All right, bye. (PAUSE) (55:23)

POLICE DESK SERGEANT MARIANO: Sergeant MARIANO.

PO HECTOR MALONE: Sergeant MARIANO, it's Hector Malone, how are you?

POLICE DESK SERGEANT MARIANO: Hey, what's up?

PO HECTOR MALONE: I'm calling with reference to ... I know you're tied up.

Are they calling us in?

POLICE DESK SERGEANT MARIANO: Well, I'll tell you what, sir, I'm calling you in.

command.

POLICE DESK SERGEANT MARIANO: At this point, I don't know what to tell

you. You can't get into the city.

BURSON MARSTELLER - PAT RILEY: Oh, no, I'm sorry. I'm talking about just

to get a phone call into somebody, who I can offer our assistance to, and then

get out of their way. If there is someone there to talk to, if I can.

POLICE DESK SERGEANT MARIANO: All the phones are out over there.

BURSON MARSTELLER - PAT RILEY: Okav.

POLICE DESK SERGEANT MARIANO: So at this point, I don't know what to

tell you.

BURSON MARSTELLER - PAT RILEY: Okay.

POLICE DESK SERGEANT MARIANO: Let the emergency people do their

thing first, you know?

BURSON MARSTELLER - PAT RILEY: Oh, yeah, yeah. I just wanted to offer

our assistance.

POLICE DESK SERGEANT MARIANO: I appreciate that, sir.

BURSON MARSTELLER - PAT RILEY: Okay, thanks.

POLICE DESK LINDA: Port Authority Police.

JEFF HAYDEN: Hey, Linda, it's Jeff Hayden. I just got a message from

POLICE DESK LINDA: Hold on.

JEFF HAYDEN: Sure. (LONG PAUSE) (PHONE RINGING)

POLICE DESK LINDA: Port Authority Police.

CAPTAIN: Linda, it's Captain Bland, over at (Overlap)

POLICE DESK LINDA: We don't have anyone. (LONG PAUSE) (PHONE

RINGING) (DIAL TONES) (BUSY SIGNALS) (PHONE RINGING)

POLICE DESK SERGEANT MARIANO: Sergeant MARIANO.

NEWARK AIRPORT - ARTIE: Yeah, it's Artie, I'm at the Newark Airport.

POLICE DESK SERGEANT MARIANO: Yeah, Artie.

NEWARK AIRPORT - ARTIE: Just hold on. Jay, what do you want to know?

Is there a number repeater for the radio? Because our radios are out.

POLICE DESK SERGEANT MARIANO: And so is everything we have, is out too.

NEWARK AIRPORT - ARTIE: Everything is out.

POLICE DESK SERGEANT MARIANO: Over at the CPD. And while I've got you on the phone, return roll calls, twelve-hour tours.

NEWARK AIRPORT - ARTIE: Twelve-hour tours, return roll calls. Okay.

POLICE DESK SERGEANT MARIANO: Okay?

NEWARK AIRPORT - ARTIE: All right. Bye. (DIAL TONE) (PAUSE) (LOUD COMMOTION) (DIAL TONES) (PHONE RINGING)

POLICE OFFICER - DESK: (Inaudible), desk.

POLICE DESK SERGEANT MARIANO: Hey, it's MARIANO. Spread the word to the tour commander, return roll calls, twelve-hour tours.

POLICE OFFICER - DESK: Return roll calls, twelve-hour tours.

POLICE DESK SERGEANT MARIANO: Correct.

POLICE DESK SERGEANT MARIANO: Hey, it's MARIANO, central desk.

spread it to the lieutenant please.

POLICE OFFICER - DESK: Okay.

POLICE DESK SERGEANT MARIANO: Thank you.

POLICE OFFICER - DESK: Okay. (PAUSE)

POLICE DESK SERGEANT MARIANO: Roger, MARIANO.

SI POLICE OFFICER JOHN: Hey, John.

POLICE DESK SERGEANT MARIANO: John ...

SI POLICE OFFICER JOHN: Hey John, did you guys turn on ... all of your

mutual aid to Staten Island?

POLICE DESK SERGEANT MARIANO: All of your mutual aid ...

POLICE OFFICER ROGER: Yeah, you got mutual aid to Staten Island. You have wire line control. We were able to turn two of them on over the air, but I can't turn the other (Overlap)

POLICE DESK SERGEANT MARIANO: How do I do it, John?

SI POLICE OFFICER JOHN: You have a control center right there at your desk. There's a Vega console there.

POLICE DESK SERGEANT MARIANO: This thing with all the switches?

SI POLICE OFFICER JOHN: No, no. You know what? Maybe I can get someone up to you.

POLICE DESK SERGEANT MARIANO: Okay.

SI POLICE OFFICER JOHN: That would be easier. Right now ... but the problem you have is I think a lot of your cops don't know how to switch.

POLICE DESK SERGEANT MARIANO: (Inaudible)?

SI POLICE OFFICER JOHN: (Inaudible) one and four. (LOUD COMMOTION)
Okay, John, one in four are operating right now. The other three, we can't get on
from here. Now, you have a procedure by the console, it should be taped to it.

POLICE DESK SERGEANT MARIANO: Okay.

SI POLICE OFFICER JOHN: To tell you how to do it.

POLICE DESK SERGEANT MARIANO: All right.

SI POLICE OFFICER JOHN: I can't call mine up right now, because my frigging computer isn't working for some reason.

POLICE DESK SERGEANT MARIANO: All right. I'll see what I can do, John.

SI POLICE OFFICER JOHN: The other thing is this, the cops have to know to switch to that. Because right now, John, I guess you know, there is no World Trade Two.

RADIO SHOP - PETE: Morgan, this is Pete from the radio shop.

PA POLICE - MORGAN: What's up guy?

RADIO SHOP - PETE: Mutual Aid One and Mutual Aid Four are operational, on

the air.

PA POLICE - MORGAN: Okay.

RADIO SHOP - PETE: You have a console there that can talk on either one.

PA POLICE - MORGAN: Okay.

RADIO SHOP - PETE: The police here are asking us, because the trunking system is down.

PA POLICE - MORGAN: Right.

RADIO SHOP - PETE: Mutual Aid One and Mutual Aid Four. I have two repeaters that are on, that you guys can use.

PA POLICE - MORGAN: Okay.

RADIO SHOP - PETE: You assign them as you need.

PA POLICE - MORGAN: Okay.

RADIO SHOP - PETE: And we are trying to get two and there up, to give you additional channels. We're working on everything that's happening.

PA POLICE - MORGAN: I appreciate that.

RADIO SHOP - PETE: Okay, bye-bye. (PAUSE) (LOUD COMMOTION)

(VARIOUS TELEPHONE NOISES) (LONG PAUSE)

(PHONE RINGING)

POLICE DESK SERGEANT MARIANO: Sergeant MARIANO.

SCHOOL COUNSELOR: Hi, this is Erin Fischer, I'm a Lacy Middle School counselor. I was wondering if Vinnie Sapola is available.

POLICE DESK SERGEANT MARIANO: He's here, he's not available.

SCHOOL COUNSELOR: He is there, and he is all right, his daughter is worried about him.

POLICE DESK SERGEANT MARIANO: All right, tell her he's okay.

SCHOOL COUNSELOR: (To daughter) He's okay.

POLICE DESK SERGEANT MARIANO: Right.

SCHOOL COUNSELOR: Thank you.
