MALE: We have a man in A Tower, C stair, 27th floor, needs assistance.

ANTHONY SAVAS: Listen, this is Tony Savas, if you can, I'm on the 78th floor, I'm trapped in the elevator. Water and debris is coming down. And I'm in Car 81-A. Please send somebody to open the doors.

MALE: (Inaudible), Ed?

MALE: Two-two, two-six, Anthony!

MALE: Stand by. Anthony's (Inaudible) trying to get (Inaudible) the radio, I have the radio. (ECHOES)

MALE: Tell Anthony to go to Church and Liberty, in front of Brooks Brothers.

MALE: (Inaudible) inside the building, think there is somebody else stuck on the ... the elevators.

MALE: (Inaudible) radio, they belong to someone else. It says ... it says "Supervisor" on it. I think the guy's fine, but he wants his radio.

MALE: That's a copy. I want everybody out of the building now!
