(BACKGROUND CONVERSATIONS - RADIO TRANSMISSIONS )

(PHONE RINGING)

MAN IN OFFICE: Eight-zero is not on the train. He's en route by car.

MAN IN OFFICE: Yes, sir?

MAN ON RADIO: Get (Inaudible) by vehicle to the Trade Center.

MAN IN OFFICE: (Inaudible) any available units, you're supposed to be going.

MAN ON RADIO: (Inaudible), okay?

MAN TO RADIO: (Inaudible) two three to respond to World Trade.

MAN ON RADIO: (Inaudible) out. (09:40)

(PHONE RINGING)

MAN IN OFFICE: Get the (Inaudible) what.

MAN ANSWERING TELEPHONE: (Inaudible), yes.

MAN IN OFFICE: Contact (Inaudible).

MAN IN OFFICE: (Inaudible) New York City Police.

(PHONES RINGING SIMULTANEOUSLY IN BACKGROUND)

(RADIO TRANSMISSIONS)

MAN ANSWERING PHONE: Police desk. (PAUSE) Yeah.

MAN ON RADIO: (Inaudible) units (Inaudible).

(TELEPHONE BEING ANSWERED)

PAPD SERGEANT HOLLAND: Port Authority Police, Sergeant Holland.

MAN TO RADIO: (Inaudible) A-1 alpha, you don't have anything (Inaudible), all right? A-1 alpha, (Inaudible).

PAPD SERGEANT HOLLAND TO TELEPHONE: Yeah, I understand, you're (Inaudible). Everybody is (Inaudible)

MAN IN OFFICE: (Overlap) mobilizing ...

PAPD SERGEANT HOLLAND: (Inaudible) and I'm (Inaudible), all right, bye.

(ANOTHER TELEPHONE STILL RINGING IN BACKGROUND)

MAN TO RADIO: Go with your message. (Inaudible) Yeah. John?

MAN CALLING : I'm trying to (Inaudible) New York City firemen ... can you (Inaudible)?

MAN RESPONDING: He's out on the job right now.

MAN CALLING: At the World Trade Center incident? (Inaudible)

MAN TO RADIO: Go, two-alpha.

MAN ON RADIO: (Inaudible) disabled (Inaudible).

PAPD SERGEANT HOLLAND: (ANSWERING TELEPHONE)

Port Authority Police, Sergeant Holland.

MAN TO RADIO: You're not going to get in by train. There's going to be no train service.

MAN IN OFFICE: (Inaudible) trade center ...

MAN TO RADIO: A-1, desk. Go, 2-alpha.

MAN IN OFFICE: Do you want to (Inaudible) roll call?

MAN TO RADIO: A-1, do you want 2-alpha to reply to World Trade, we got no train service.

(SIMULTANEOUS CONVERSATIONS TAKING PLACE ON AND OFF  
TELEPHONES AND RADIOS) (12:27)

FIRE DEPARTMENT FEMALE: (ANSWERING TELEPHONE) (Inaudible) 328.

Fire Department, 328, hello?

PA TOM CASHIN: Three-two-eight, this is Cashin Port Authority. Are you aware of the Trade Center incident?

FIRE DEPARTMENT FEMALE: Yes, we are on the scene there.

PA TOM CASHIN: All right.

FIRE DEPARTMENT FEMALE: Okay.

PA TOM CASHIN: Thank you.

FIRE DEPARTMENT FEMALE: Thank you. (PAUSE - SOUNDS CUT OUT)

(PHONE RINGING, NO ANSWER, THEN CUTS OUT - NO SOUNDS OR  
CONVERSATION UNTIL SERGEANT DEKALB IS HEARD VERY FAINTLY)

SERGEANT DEKALB: Hello, this is Sergeant Dekalb , of the Port Authority,  
(Inaudible). We are sending over (Inaudible) there to help out the Port Authority guys.

PATH CH. 15 - NYPD

(Inaudible) to do? All right, (Inaudible), okay? Help the Port Authority out. They're just (Inaudible) over there, (Inaudible) control. (Inaudible) traffic going in and (Inaudible).

One guy (Inaudible) Port Authority. All right. (01:03:26)

(NO CONVERSATION OR SOUNDS EXCEPT FOR OCCASIONAL VERY FAINT TELEPHONE RINGING WHICH IS NOT ANSWERED)

(VERY FAINT VOICES ARE HEARD AT 01:30:48)

SERGEANT KITANO: Uh, Kitano, Port Authority. Uh, (Inaudible) guys from Port Authority get down the ramp and (Inaudible) the Palisades, the highway? (PAUSE)

(Inaudible), okay, thank you. (END OF CONVERSATION)

(LONG PAUSE)

(VERY FAINT VOICES ARE HEARD AT 01:30:46 - INAUDIBLE)

MALE: (Inaudible) go. You bet. If you can, send five more over here, once you get things organized. All right, (Inaudible). All right. Okay? So (Inaudible) get some security here. No, no, the Port Authority is putting everybody over at the two (Inaudible), help (Inaudible) there. No, no, we are getting security for the (Inaudible), okay? All right, bye.

(VERY FAINT)

MALE: (Inaudible) here. Uh, we have one officer who is (Inaudible), we need somebody in the lobby. (PAUSE) Yeah, have them go down to (Inaudible), okay?

MAN TO RADIO: Tell (Inaudible)

(OUTGOING PHONE CALL)

FIRE DEPARTMENT - 242: Fire Department, this is (Inaudible) 242. What's the address of the fire?

PATH COMMUNICATIONS: Uh, there's no fire. This is PATH communications, over at the PATH Police Center, Jersey City. We are making sure that the line is working.

FIRE DEPARTMENT - 242: Okay, yes, it's working perfect.

PATH COMMUNICATIONS: Thank you very much.
