MALE OPERATOR: Any Lincoln Tunnel uniform personnel, (Inaudible) but any Lincoln Tunnel uniformed Port Authority personnel can assist.

MALE ESSEX: Okay, read you (?). (03:08:49)

MALE BERGEN: Chief of Bergen County Sheriff Department on SPEN 1. (PAUSE)

MALE HOLLAND TUNNEL PA: (Inaudible) Port Authority Holland Tunnel.

CONFIDENTIAL – ATTORNEY/CLIENT PRIVILEGE

MALE C: (Inaudible), do you have enough handlers (Inaudible) at the back of the building?

MALE BERGEN: Bergen County Police, Port Authority, Holland Tunnel.

MALE OPERATOR: Bergen County Police, this is Port Authority central, what is your message?

MALE BERGEN: Advise Holland Tunnel that it is going to be 40 minutes for the console.

MALE OPERATOR: Okay, we copy that, thank you.

MALE C: (Inaudible)

MALE ESSEX: Essex County, calling Port Authority.

MALE OPERATOR: Go ahead, Essex County.

MALE ESSEX: Roger, Essex County, sending (Inaudible) personnel, report to New Jersey toll plaza at the Lincoln Tunnel. Copy? (03:09:48)

MALE OPERATOR: Okay, the New Jersey toll plaza, Lincoln Tunnel.

MALE ESSEX: That's affirmative. All agencies from Port Authority Central Police Desk, did you copy? Any emergency personnel (Inaudible) assigned to the Lincoln Tunnel New Jersey toll plaza. That will be the staging area, for anyone, any emergency personnel, copy? (PAUSE)

MALE BERGEN: Bergen County Sheriff, Port Authority Central.

MALE OPERATOR: Go ahead, Bergen County.

MALE BERGEN: Do you need a cadaver dog yet?

MALE OPERATOR: That's affirmative, sir, send them, thank you.

CONFIDENTIAL – ATTORNEY/CLIENT PRIVILEGE

MALE C: We can use any equipment from any agency, going to the Lincoln Tunnel, any and all equipment.

MALE OPERATOR: If you have any extra gloves, hats, bring it.

MALE C: We need flashlights, batteries, water, all equipment. (PAUSE)

MALE A: (Inaudible) police to Port Authority on SPEN 1.

MALE OPERATOR: (Inaudible) Port Authority.

MALE A: The staging area is outside of the Holland or Lincoln?

MALE OPERATOR: No, sir, the staging area is now at the Lincoln Tunnel, everything has been reassigned to the Lincoln Tunnel.

MALE A: Okay, received.

MALE B: Medical personnel responding to Ellis Island, medical personnel only, for victims to be transported to Ellis Island. All Police personnel should go to Lincoln Tunnel.

MALE A: (Inaudible), the medical personnel at Holland?

MALE OPERATOR: Medical personnel are to respond to Ellis Island, copy? Ellis Island will be set up as a triage area. (03:11:22)

MALE SIV: Port Authority Central on SPEN 1 from SIV.

MALE OPERATOR: Go ahead, SIV.

MALE SIV: You have two PO's entering the Holland about two minutes away, do you want us to divert it to Lincoln?

MALE OPERATOR: Negative, triage, let them go.

CONFIDENTIAL – ATTORNEY/CLIENT PRIVILEGE

MALE SIV: Roger.

MALE BERGEN: Bergen County, Port Authority, where do you want that cadaver dog?

MALE OPERATOR: Sir, send them to the staging area at the Lincoln tunnel. They will be escorted down to the triage center. Copy?

MALE BERGEN: Received. (PAUSE) (03:12:03)

MALE STATE POLICE: Port Authority from State Police on SPEN.

MALE OPERATOR: State Police, this is Port Authority central, go.

MALE STATE POLICE: Okay, we are changing the command post over to Lincoln Tunnel, you said the entrance on the Jersey side at the toll?

MALE OPERATOR: That's affirmed. Staging area, for all Jersey emergency personnel is going to be the Lincoln Tunnel by the toll lane, New Jersey side, the teletype is going to be sent out statewide.

MALE STATE POLICE: Thank you. (PAUSE) (03:12:37)

MALE POLICE JC: Jersey City Police to State Police. (PAUSE) (03:13:13) Jersey City Police to State Police. (PAUSE)

MALE STATE POLICE: New York State Police, CPD.

MALE POLICE PA: Port Authority Central Police.

MALE POLICE: (Inaudible) police.

MALE POLICE JC: Do you know which hospital in Jersey City they're using for the overflow of victims? The victims (Inaudible) to aid?

CONFIDENTIAL – ATTORNEY/CLIENT PRIVILEGE

MALE POLICE PA: Ellis Island is the triage center. Medical personnel are responding there. I'm trying to find out what hospital is being used.

MALE POLICE JC: Do not know at this time which hospital?

MALE POLICE PA: I do not know but I will try to find out for you. (03:14:23)

MALE STATE POLICE: Port Authority from the State Police on SPEN.

MALE OPERATOR: Go, State Police.

MALE STATE POLICE: Port Authority, if you copy, (Inaudible) at 29, call number, if we can have a phone number where we can reach you so they can be in direct contact with you.

MALE OPERATOR: Okay, our Central Police Desk phone number is 201-216-6800. that's 201-216-6800.

MALE STATE POLICE: Received that correctly, (Inaudible) CP correct, sir.

MALE OPERATOR: That's affirmed.

MALE STATE POLICE: Thank you. (PAUSE) (03:15:02)

FEMALE OPERATOR: Passaic County Sheriff's Department, municipality requesting the dogs. Passaic County Sheriff's Department, unit requesting a canine. (PAUSE) Passaic County Sheriff's Department, the (Inaudible) municipality requesting a cadaver dog. (PAUSE) (03:16:03)

MALE BERGEN: Bergen County to Passaic County.

FEMALE OPERATOR: Stand by, we've got a Passaic County.

MALE BERGEN: Port Authority Central is looking for cadaver dogs, there's a staging area at the Lincoln Tunnel at the Port Authority ...

MALE A: Get an ambulance! (PAUSE) (03:16:20)

MALE OPERATOR: That's affirmed, this is Port Authority Central, Passaic County. If you could bring any cadaver dogs to Lincoln Tunnel, the toll end at the New Jersey side, they will be escorted over.

FEMALE OPERATOR: (Inaudible). (03:16:40)

MALE CVM: CVM-1 calling Port Authority at George Washington Bridge. (PAUSE)

MALE STATE POLICE: Unit State Police, CPD(?). (PAUSE)

MALE CVM: CVM-1 calling the Port Authority, George Washington Bridge.

(PAUSE) FEMALE STATE COUNTY SHERIFF: State County Sheriff calling Port Authority on SPEN.

MALE OPERATOR: State County, go.

FEMALE STATE COUNTY SHERIFF: We contacted the (Inaudible) 1-7500.

MALE OPERATOR: Repeat that number please?

MALE BERGEN: Bergen, (Inaudible) George Washington Bridge. (PAUSE)

MALE OPERATOR: Passaic County, you're coming broken up. If you can contact us, that's 201-216-6800. Do you copy? 201-216-6800.

MALE BERGEN: Police to Port Authority, GW Bridge. (03:17:37)

MALE OPERATOR: (Inaudible) Port Authority, George Washington Bridge. This is Port Authority Central, can I help you?

CONFIDENTIAL – ATTORNEY/CLIENT PRIVILEGE

MALE BERGEN: Central, this is Woodridge Police, Bergen County. I have a fire department (Inaudible) of approximately eight pieces of equipment about a half mile from your destination, which is at the Port Authority headquarters at GW Bridge, stuck in traffic, is there any assistance because they need it to open up some lane so they can get to the bridge.

MALE BERGEN: I got this word from my fire department, they are reporting that they are approximately a half a mile from their destination, just sitting in traffic. And I'll let them know if they could try to get the bridge plaza (Inaudible).

MALE OPERATOR: Copy that. (03:18:28)

MALE STATE POLICE: This is State Police, (Inaudible).

MALE OPERATOR: State Police, this is Port Authority Central, go.

MALE A: (Inaudible) SPEN 1.

MALE MEDICAL M.D.: I'm an M.D. en route to help. I'd like to know where the best place is for me to go. Is it best to go to triage, over on Ellis Island? And where are they needing to take people?

MALE TENAFLY: Tenafly to Englewood on SPEN 1.

MALE OPERATOR: Tenafly, give them a call on the phone. (PAUSE)
