MALE - LINCOLN TUNNEL: Shut down (Overlap)

PAPD MULLIGAN - POLICE DESK: Okay, as of now, we are shutting everything down.

PAPD MULLIGAN - POLICE DESK: That's going to take me a little while to work that out.

PAPD MULLIGAN - POLICE DESK: Okay, my ... off the top of my head, the primary would be New Jersey College of Medicine and Dentists, University Hospital, Newark.

MALE CALLER: (Inaudible)

PAPD MULLIGAN - POLICE DESK: That's probably the best place. It's the best trauma center in North Jersey.

MALE CALLER: (Inaudible)

PAPD MULLIGAN - POLICE DESK: I would ... all right, I would say University of Newark and Hackensack (Overlap)

MALE CALLER: (Inaudible)

PAPD MULLIGAN - POLICE DESK: Okay. Even though ... okay.

MALE CALLER: (Inaudible)

PAPD MULLIGAN - POLICE DESK: Okay. Mulligan, right.

MALE CALLER: (Inaudible)

PAPD MULLIGAN - POLICE DESK: Okay, thanks.

FEMALE: Okay, we have (Inaudible).

PAPD MULLIGAN - POLICE DESK: Thank you, all right. (To personnel at the station) I'm on the phone with the State Police now, guys.

FEMALE: State Police (Inaudible).

PAPD MULLIGAN - POLICE DESK: How are you doing, Officer Mulligan, Port Authority Police.

FEMALE: Yes.

PAPD MULLIGAN - POLICE DESK: I assume you are aware we have a problem in Manhattan right now.

FEMALE: That's correct.

PAPD MULLIGAN - POLICE DESK: Okay, New York City Police Operations are requesting the possibility of an assist with moving critically injured to trauma centers in Northern (Overlap)

FEMALE: (Inaudible).

CPD – CH. 027 – PHONE – TTY NY (2) (201) 216-6800

PAPD MULLIGAN - POLICE DESK: Thank you.

FEMALE: You're welcome.

SGT ROGER MARTIN: Roger Martin, how may I help you.

PAPD MULLIGAN - POLICE DESK: Sarge, Officer Mulligan, Port Authority Police.

SGT ROGER MARTIN: Yeah.

PAPD MULLIGAN - POLICE DESK: We've got a problem in the city. And New York City Police Operations are trying to find out about getting critically injured to trauma centers in New Jersey. We are looking at possibly Hackensack and University of Newark. Is there any chance your guys can contact New York City aviation, because I think aviation is going to be snowed under, as soon as they start doing something.

SGT ROGER MARTIN: I know that they shut down every bridge and tunnel.

PAPD MULLIGAN - POLICE DESK: Okay, we got everything shut down inbound to New York. We are only allowing limited traffic out. We've shut down Kennedy, and we are in the process of shutting down La Guardia and Newark, I believe.

SGT ROGER MARTIN: (Inaudible).

PAPD MULLIGAN - POLICE DESK: Thank you, thank you. (PAUSE) (To personnel at the station) I'm on the phone with the State Police. We're trying to ... okay. I'm on the phone with the State Police. We are trying to coordinate their guys and (Overlap)

PERSON AT STATION: (Inaudible).

PAPD MULLIGAN - POLICE DESK: Well, I'm trying to get their dispatch guy to look them up with New York City Aviation, so they can work ... Hello?

SGT ROGER MARTIN: Hold on.

PAPD MULLIGAN - POLICE DESK: Thank you. (PAUSE)

POLICE OPERATIONS SERGEANT: Operations, this is (Inaudible).

PAPD MULLIGAN - POLICE DESK: Sarge, Officer Mulligan, Port Authority. Okay, Sarge, we got a handful right now. We got a problem in Manhattan, that seems to be ...

POLICE OPERATIONS SERGEANT: Yes, I am well aware.

PAPD MULLIGAN - POLICE DESK: Okay, okay. Our problem now is New York City Police have contacted us and they ... they're convinced there is going to be a problem moving critically injured to trauma centers in New Jersey. We are looking at the University of Newark, and probably Hackensack. They are wondering if there is a possibility that your aviation units could possibly coordinate with their guys, to set something up in ...

POLICE OPERATIONS SERGEANT: (Inaudible).

PAPD MULLIGAN - POLICE DESK: Okay, good. I ... I got a call from them, so they were ... they were reaching out to us, thinking we might have a better number.

POLICE OPERATIONS SERGEANT: (Inaudible).

PAPD MULLIGAN - POLICE DESK: Okay. Okay.

POLICE OPERATIONS SERGEANT: (Inaudible).

PAPD MULLIGAN - POLICE DESK: I'm ... I'm, they ... they were in the process of trying to switch me over to their op center.

POLICE OPERATIONS SERGEANT: (Inaudible)

PAPD MULLIGAN - POLICE DESK: How are you doing, it's Mulligan, Port Authority Police. Okay, guy, listen, we've got the Jersey State Police helicopters. They are going to contact your guys to coordinate. I got a call from Tepper, I guess, that he wanted to know about trauma centers. Now, the Jersey State Police can stage as many ambulances as necessary, if we tell them what our needs are.

CALLER: Okay.

PAPD MULLIGAN - POLICE DESK: So I don't know ... I've got a phone number I can give you. And it's their coordination center. And they can arrange for the ambulances on the Jersey side of the river.

PAPD MULLIGAN - POLICE DESK: Okay. Okay, it's Now, that's going to give you North Star, which is their MediVac helicopter. Just tell them what ... how many ambulances you think you need, and what they'll do is they'll coordinate through Mutual Aid, New Jersey.

CALLER: Now, what's your name?

PAPD MULLIGAN - POLICE DESK: Mulligan.

CALLER: Oh, Port Authority, right?

PAPD MULLIGAN - POLICE DESK: Yup.

CALLER: Very good.

PAPD MULLIGAN - POLICE DESK: Okay, no problem. Thank you, bye.

PAPD MULLIGAN - POLICE DESK: Okay.

CALLER: (Inaudible)

PAPD MULLIGAN - POLICE DESK: Right, right. Everything is shut (Overlap)

CALLER: (Inaudible), the helicopters, (Inaudible) any suggestions .

PAPD MULLIGAN - POLICE DESK: Well, the only thing I can tell you at this point, we can try to get NYPD ops. Because we can't get our helicopters, because we've got to beep them, and all the beepers are out. I can (Overlap)

CALLER: (Inaudible) frees all ...

PAPD MULLIGAN - POLICE DESK: Yeah, yeah, yeah. Now, what I can do is, you know what? You might ... you might get farther than I can.

CALLER: Okay.

PAPD MULLIGAN - POLICE DESK: I'll give you a number for NYPD ops, okay?

CALLER: Who's the sergeants?

PAPD MULLIGAN - POLICE DESK: I've got Sergeant Murriano and Sergeant Lozack. At this point, if you think it's a good thing to do, and they've got a bird to move you ...

CALLER: All right, give me the phone number.
